



#### **EDITORIAL**

Dear Readers,

As in the previous editions, we are happy to produce and present key highlights of the operations of the Examinations Council of Zambia (ECZ). There is a general view, and rightly so, that the traditional examination system does not bring out the real ability, achievement, or potentiality of candidates at all the levels. Hence, there is a need for examination reforms. Arising from this, most of the articles in this edition showcase and highlights progressive reforms which the ECZ and the Ministry of General Education is implementing to achieve quality education in Zambia.

Seen in this perspective, school education is of prime importance for the all-round development of the Zambian child. This is because it is where they first access the requisite know-how essential for standing up to the demands of modern life. Examinations or assessments of learners in any given society, play a very important role in deciding the quality of education.

Within the period under review, the ECZ has embarked on reforms aimed at bringing efficiency and effectiveness in the general conduct of examinations. The reforms also align assessment tools and practices to regional, continental and global standards. The ultimate goal through the examination reforms is not only to assess learner's achievements (and grades) but also measure whether the desired learning outcomes have been attained. The ECZ implemented the School-Based Assessments (SBA) to enhance the syllabus coverage in assessing learner competencies and skills. The SBA is part and parcel of the teaching and learning process.

As a remedy to curb the occurrences of examination malpractices, the ECZ working jointly with different education stakeholders at provincial and district levels, have identified centralised points where the storage of examination related materials will take place with heightened security. The aim is to create a centralised storage facility to avoid misuse and tampering of examination materials. Related to this is the fact that effective 2019, the examination period has been reduced from the initial three (3) months to only one month. This reform has been necessitated by the introduction of the SBA which will now take place at school level.

Other reforms are related to the review of the examination syllabi for Grades 7, 9 and 12 examinations. The process includes reforming the interpretation of results for the Grade 7 examination and the review of the examination paper structures for all the ECZ set examinations. The ECZ has also invested in automating the process of test development to reduce human involvement in the construction of test items. Once the Electronic Item Banking System is implemented by 2020, there will be full accountability for those involved in the setting of examinations through the system and the ECZ will drastically reduce the cost of test development.

As guided by the Ministry of General Education, the ECZ will always premise its mandate and operational activities on creativity and innovations to meet the aspirations of the Zambian people. We are further committed to reforming the examinations system to ensure that the Zambian school qualifications continue to be credible and recognised globally. Over and above this, the ECZ will remain consultative in the process of implementing the examination reforms. To you our esteemed readers, enjoy reading the 14th edition of our corporate bulletin.

# We are moving on with Innovations

It was time to look back and think about the business we are engaged in and re-engineer our systems. We believed in what Nelson Mandela had said that it was not about how many times we had fallen, but about how many times we had woken up and forged ahead after falling.

We started 2019 by finalising the processing of School Certificate (Grade 12) and Teacher Education examination results, before we moved to review the conduct of the 2018 examinations to draw lessons for the intended examination reforms. The examination reforms were both part of one of our Strategic Goal to enhance efficiency and effectiveness and our response to the factors that may have facilitated the leakages of examinations in 2018. The reforms affected the entire cycle of examinations from test development, through examination administration to dissemination of results.

In the area of test development, we moved to develop an Electronic Item Banking and Test Construction system. The system aims at enhanced security of test items (questions), enhanced accountability for those involved in drafting of test items and the entire process of setting question papers. Additionally, we reviewed our examination syllabi by meticulously screening all subjects and papers, identifying all learning outcomes that were defined in the teaching and learning syllabi, eliminating duplications of learning outcomes across papers, realigning practical oriented learning outcomes to the newly introduced School Based Assessment (SBA) and developing the Guidelines for the Administration of School Based Assessment in Zambia.

By the end of the first six months of 2019, we had reviewed the examination syllabi and resolved to introduce School Based Assessment (SBA) from Grade 5 to Grade 12. We had also developed a system for online transfer of SBA marks from the schools to ECZ, reviewed the number of examination papers from 47 to 30 at Grade 9, and from 74 to 50 at Grade 12 levels. We had determined the weights at primary school level at 30% SBA and 70% final examination paper

for each subject. We had resolved that SBA marks at primary school level would be spread over three years for each subject, with a maximum of 10% per subject be accrued by the candidates for the Grades 5, 6 and 7. We implemented the SBA for practical papers for all Grade 9 and 12 candidates.

In the area of Examinations Administration, we realigned the timetables by introducing a third session and removing all practical papers since they were to be assessed through school based activities. This led to a reduction in the examination period by four (4) weeks, leaving it at one month instead of the two months it used to take to conduct the examinations. We zoned Examination Centres to ensure that majority of schools did not keep examination papers in advance any more, but that they would receive question papers on a daily basis. This was done to enhance the security of papers. We implemented SBA for practical examinations at Grades 9 and 12 levels and deployed the system for transferring SBA marks online and developed a system to enable introduction of Online Statements of Results. Effective this year (2019), we will no longer print and distribute Statements of Results, they will be accessed online. We initiated another innovation for the establishment of the Online Results Verification System (ORVS). The ORVS is expected to benefit the individuals, higher learning institutions and would be employers as they will be able to verify certificates in the comfort of their offices and homes, when it is deployed before end of December, 2019.

We wish to encourage all our stakeholders to move along with us as we pursue our Mission to Efficiently Conduct Assessment and Award Certificates of Comparable International Standards by reading this Newsletter.

# ECZ implements School-Based Assessments to Achieve Quality Education By Nicolas Nkhuwa

...It is part and parcel of the teaching and learning process

The Examinations Council of Zambia (ECZ) has embarked on reforms aimed at bringing efficiency and effectiveness in the conduct of examinations and also align assessments tools and practices to regional, continental and global standards.

Effective 2019, the Ministry of General Education through the ECZ will implement School-Based Assessment (SBA). This reform will enhance syllabus coverage in assessing learner competencies and skills. The SBA will see schools conducting practical school assessments were teachers will prepare assessment tasks and score the marks that will later be transmitted to ECZ through an online Portal. This will result in quick processing and timely release of examination results. The SBA marks will form part of the final mark in the final examination.

The SBA not only helps to avoid a one-off test that assesses fewer skills, techniques, handling fewer apparatus and teaching to the examination but also widens the skills and techniques to which learners are exposed and remedial interventions can be done in order to ensure skills and knowledge acquisition by the learners. During a visit to the ECZ office, the Permanent Secretary of Administration in the Ministry of General Education, Dr Jabbin Mulwanda said "School-Based Assessments is a way to go."

Further, to ensure reliability and validity in the SBA. The ECZ in consultation with the Ministry of General Education and other stakeholders has developed and distributed SBA Guidelines to schools. The guidelines are set to provide general and subject specific instructions to teachers, heads of departments, and schools in general on how to conduct the SBA and projects for the year 2019 and beyond.

The 2019 practical examinations will become part of the teaching and learning process.

At Grade 7 level, SBA will commence in 2020 at Grade 5 and learners will be assessed through both SBA and a final examination paper in all five subjects namely: English, Zambian Language, Mathematics, Social Studies, Science and Creative and Technology Studies. The SBA at this level will include formative ways of assessment to ensure adequate assessment of prescribed skills and competencies in the defined learning outcomes in each of the taught subjects. A 30% mark from SBA will be spread out from Grade 5, 6 and 7 with each level constituting 10% of SBA marks accumulating to a total of 30% while the final examinations will contribute 70% of the total marks, making

The performance of learners in any test or assessment requires recognition. This in its sense acts as a motivation to both the teachers and learners and gives especially learners, a mind shift to continue working hard to maintain such performance. This is exactly what St. Jeff College Primary School of South Africa did. On Saturday, 30th March 2019, the school held a Certificate Awards Ceremony for the first cohort of Grade 7 learners who sat the Examinations Council of Zambia (ECZ) Grade 7 Composite Examination in 2018. As you may be aware, ECZ conducted the first ever Grade 7 Composite Examinations at this school in South Africa following the successful signing of the Memorandum of Understanding in 2017.

The ECZ was invited to attend this important event to encourage and honour the learners and to strengthen the relationship between the school and ourselves as an Examining Body. It is also worth noting that this school is expanding to open other schools in New York, USA and in Cape Town were the proprietor has indicated his plans to have ECZ set examinations for them at Grade 7 and 9 levels.

### **Candidate Registration to** commence in October 2019

The 2020 registration of candidates is set to commerce in October 2019. All eligible Candidates are required to visit their Examination Centre to register for the 2020 examinations.

Similarly, parents are encouraged to ensure that their children submit the correct names especially at Grade 7 level as the details captured here will be used to sit the Grade 9 and 12 Examinations, respectively.

The registration for Grades 7, 9 and 12 is set to start on 1st October 2019 and end on 31st December 2019 while that of the Grade 9 External and GCE Candidates will start on 1st October 2019 and end on 31st January 2020.

The ECZ will not take in any late entry registration as this has potential to derail the timely procurement and delivery of examination materials to the Centres.

We therefore encourage the school administration to commence registration of candidates once the Online Candidate Registration System has been opened in October this year.

### **Centralised Points identified to enhance Examination Security**

# Characteristics of the **21st Century**Skills Assessment

During the agrarian revolution, what was valued most in a person was what they could do. During the Industrial Revolution, what was valued most was what a person knew – knowledge revolution. In the 21st century we are in the information age where the most valued skills are how well a person thinks and uses information.

There is a global shift in education towards complex skill sets like collaboration, creativity, critical thinking, communication and curiosity. The 21st century skills are skills that are essential in the age of the internet. They are skills needed to adapt to the internet age. They are in three categories namely learning, literacy and life skills

The Learning skills (the 5Cs) teach students about the mental processes required to adapt and improve upon a modern work environment. The most popular 21st century skills are: Critical thinking, Creativity, Collaboration, Communication and Curiosity. The Literacy skills which are sometimes called IMT skills - digital comprehension consist of: Information literacy which understanding facts, figures, statistics and data, Media Literacy refers to understanding the methods and outlets in which information is published and Technology literacy - understanding the machines that make the information age possible. The Life skills is the final category. They are also called FLIPS, these skills all pertain to someone's personal life, but they bleed into professional settings. These are Flexibility, Leadership, Initiative, Productivity, Social skills.

However, in this edition, I will highlight the key characteristics of the 21st century skills assessment. The following eight characteristics of 21st century assessment are essential guide for preparation of assessment activities by educators. It is necessary to refer to these characteristics to ensure that the learners are being assessed towards the skills and demands of the 21st century.

#### 1- Responsive

The 21st century assessment should be visible performance-based work (as a result of assessment) generates data that inform

curriculum and instruction. For example in a Literature class, a teacher can discuss Literature and some Literary works. For a teacher to know if the class understood the lesson, the teacher will conduct a formative assessment. In a quarter sheet of paper, the learners will answer the question: "How does Literature mirror your life?" and "What literary work mirrors your life?"

#### 2-Flexible

Assessment need to be adaptable to students' settings rather than the identical approach that works in traditional assessment, 21st century approaches are more versatile. For example in a Principles of Teaching first year class at College, the teacher can let students have a survey on their Multiple Intelligences. After that, the teacher groups the students according to their intelligences and let them have a creative presentation.

#### 3-Integrated

The 21st century assessments are to be incorporated into day-to-day practice rather than as add-ons at the end of instructions or during a single specified week of the school calendar. For example a teacher can assess his/her students from time to time because assessments are not just given at the end. The teacher can give his/her students formative assessments rather than just giving them summative assessments.

#### **4-Informative**

The desired 21st century goals and objectives are clearly stated and explicitly taught. Students display their range of emerging knowledge and skills. Exemplars routinely guide students toward achievement of targets. For example, before a teacher starts his/her class, he/she should see to it that his/her students are aware of the goals and objectives. With that, the students will be guided with their achievements.

#### **5-Multiple Methods**

The 21st century assessment consists of an assessment continuum that includes a spectrum of strategies which is the normal practice. For example, in a teacher's classroom there are students having different intelligences, so the teacher should see to it that he/she does not focus on only one way of assessing their learners.

#### 6-Communicated

The 21st century assessments require that it is communicated. Communication of assessment data is clear and transparent for all stakeholders. For example, a teacher should let his/her students keep track of their progress by returning their papers or evaluation sheet. The teacher should also see to it that he/she submits his/her students' grades on time for their parents to be aware of their child/children's achievements.

#### 7-Technically Sound

The 21st century assessment should be technically sound. Adjustments and accommodations are made in the assessment process to meet the students' needs and fairness. For example, the teacher should make sure that the assessments are valid, reliable and support comparisons since the students have different intelligences, beliefs, gender and socio-economic groups.

#### 8-System

The 21st century assessment is part of a comprehensive and well-aligned assessment system that is balanced and inclusive of all students, constituents, and stakeholders and designed to support improvement of all levels. For example, since changes are inevitable, the teacher should make sure that he/she is able to identify the needs of his/her students and the community. With that he/she will be able to develop his/her students into globally competitive individuals.

From the foregoing, assessment plays a critical role in setting standards and influencing curricula at the local, regional, national and global level, so it is expected that these new assessments will motivate schools to do more to instill 21st century skills. Because 21st century skills are comparatively more complex, non-routine and dynamic, the measurement process needs to take into account their application in real life and non-familiar situations.

# Highlights of the 2018 School Examinations By Sm

# School Certificate (Grade 12) Examination

The total number of candidates who entered for the 2018 Grade 12 examination was 121,299 of whom 64,202 (52.93%) were boys and 57,097 (47.07%) were girls. This represents a decrease in candidature of 10.03 percent from 2017. The candidature of boys decreased by 12.35% percent while that of girls increased by 7.26% percent.

Of the 121,299 who entered the examination, 119,383 candidates comprising 63,172 boys and 56,211 girls sat the examination. The total number of candidates who were absent from the examination was 1,916, that is 1, 030 boys and 886 girls.

In terms of performance, the proportion of candidates obtaining School Certificates in the 2018 examination session decreased by 1.40 percentage points from 64.84 percent in 2017 to 63.44 percent in 2018. Further analysis on the performance of candidates, reveals that the proportion of boys who obtained School Certificates was higher at 65.14 percent than that of girls which was at 61.53 percent.

## Junior Secondary School Leaving (Grade 9) Examination

A total of 284,523 candidates entered for the 2018 Grade 9 Junior Secondary School Leaving Examination compared to 350246 in 2017. This represents a decrease of 18.76 percent over the candidates that entered for the same examination in 2017. Disaggregating the number of candidates who entered the examination by sex, a total of 141,704 (49.80 %) were boys and 142,819 (50.20 %) were girls.

In terms of performance, a total of 116,616 candidates obtained certificates; representing 45.65 percent of the total candidates that sat the examination. This represents a decrease of 9.54 percentage points from 2017. More girls (63,009 or 49.35%) obtained Statements than boys (61,439 or 48.08%). More boys (7,359 or 5.76%) failed the examination than girls (7,026 or 5.50%).

# **Grade 7 Composite Examination**

A total of 443,700 candidates entered for the 2018 Grade 7 Composite Examination compared to 400,802 in 2017. This represents an increase of 10.7 percent over the candidates that entered for the same examination in 2017. Segregation of the number of candidates who entered the examination by sex, a total of 219,658 (49.51%) boys and 224,042 (50.49%) girls entered for the examination. Out of the 443,700 who entered for the examination, 388,442 candidates sat the examination, of whom 192,723 (49.61%) were boys while 192,719 (50.39%) were girls. This figure includes 111 candidates from St Jeff College Primary School of South Africa who also sat the same examination.

There were a total of 239,024 candidates obtaining Divisions 1, 2 and 3; representing 61.53 percent of the total candidates that sat the examination. A total of 149,307 candidates obtained Division 4, the least grade; representing 38.44 percent. Further Analysis of results along the lines of gender revealed that boys performed better than girls in all the subjects except English.

In terms of the progression rate to Grade 8, all the 388,331 candidates who sat the 2018 Grade 7 Composite examination were selected to Grade 8, bringing the national progression rate to 100.00 percent from 99.14 percent in 2017. The improvement in the national progression rate is an indication that school places have been created at secondary school level by the government of Zambia.

### **International Assessment Network Vital for Examining Boards**

... As they Probe the Future of Examinations

The Cambridge Assessment Network (CAN) which is part of Cambridge Assessment (CA), Europe's largest assessment agency and a department of the University of Cambridge, hosts the Cambridge International Study Programme (CISP) on an annual basis. The 2019 CISP took place from 13th to 23rd May 2019 at Cambridge Assessment in Cambridge, United Kingdom.

The study programme was attended by six (6) countries drawn from 2 continents, Africa and Asia. The ECZ was present at the program that focused on two main themes–development and administration and processing of examinations. These were further broken down into principles and practices of assessment design, developing assessment frameworks, administration of examinations and the future of assessments.

Amongst the lessons learnt were that examining boards should help learners demonstrate and fulfill their potential. In doing so, some of the organizations' core values should include collaboration among officers and stakeholders, being innovative, accountable and responsible. In high stake assessments, monitoring of schools should

be encouraged so that the successful interactions between the internal and external staff should be aimed at supporting and not judgmental, in order to help improve matters.

School-based assessment should be well designed so that it is practicable and the results obtained should be both valid and reliable. Replacing practical examinations with school-based assessments not only helps avoid a one-off test that assesses fewer skills, techniques, handling fewer apparatus and teaching to the examination but also widens the skills and techniques to which learners are exposed.

E-assessments are being adopted by many examining boards. The term denotes any type of assessment that has an electronic component and incorporates one or more of e-testing, e-portfolios and e-marking. E-assessments are comparable to paper-based assessments in terms of containing a fixed number of questions, test duration, responses either human or auto-marked.

It was also discussed that in mark schemes designing, there should be a good connection between items and the marking scheme. In this respect, good items need to be readable, understandable and closely aligned with the target syllabus or construct.

On the recommendations which were found to be useful for Zambia were the use of item banking in question paper production, On-screen marking, Introduction of school-based assessments, having a clearly defined approach to examination delivery challenges that enhances security of examination materials and appreciation of technology in the assessment systems.

The Cambridge International Assessment Programme had provided the participants a lot of insight into the process of delivery of high stakes assessments. It was clear from the presentations and contributions from other countries that the ECZ was on the right course particularly to make a number of innovations such as introducing school-based assessments, reducing the examination period, embracing item banking and generally adhering to the key principles of test development.

- 4. Mr. Smart Sakala, Senior Research Officer.



In order to address the gap towards harmonization in assessment, the members worked on "Similarities and differences in competences and assessment standards across the SADC region".

# Common Mistakes Made During Candidate Registration

Globally, candidate registration is an important activity in the general administration and management of examinations. It is an integral process which help the ECZ run credible and efficient examinations. Through our various communication and feedback platforms, the ECZ has noted that the majority of the candidates who sit ECZ examinations are mostly at a loss when it comes to writing examinations and certification. This is because they do not or hardly pay particular attention to the registration process,. Simply put, they do not adhere to the prescribed guidelines for the registration of candidates. In this edition, I will try to explain what prospective candidates should do as they register for the ECZ examinations.

From the outset, registration of candidates is one of the activities examination bodies undertake in order to fulfil their mandate of conducting examinations and awarding certificates to deserving candidates. A fair and equitable candidate registration process is important to maintain the integrity of the examination process. A clear, standardized and reasonable process facilitates the equal treatment of prospective candidates and helps ensure each candidate has an equal opportunity to register and sit the examinations. Adherence to the registration process gives the ECZ the actual number of eligible candidates for the examination. The registration data also ascertain the amount of examination question papers to be printed in line with Government policy. Accurate registration details helps avoid post examination queries.

Regrettably every year, the ECZ receives queries to do with mispelt names, name and subject omission and incorrect information on the candidates personal details. This challenge is mostly manifested during and after the examinations. It is prominent when the examination results are officially announced by the Ministry of General Education and candidates obtain their statement of results and collect their certificates. From our analysis, the most culprits are the GCE candidates who barely find time to verify their registration details from the examination centre.

The reason is simple. Most of the candidates do not take time to fully adhere to the registration guidelines from the ECZ which are always available at the examination centre in advance before commencement of candidate registration. We should note that the entry point for the ECZ to understand, correctly capture and accept the candidate entries is the examination centre. In the approved examination centres, the ECZ has endeavoured to build human capacity for them to register candidates using the Online Candidate Registration System (OCRS). Ideally, the centre should correctly capture the candidates details and ensure candidates pay the prescribed examination fees where applicable.

It is extremely important that prospective candidates should ensure that the examination centre correctly captures their details in the OCRS. The centre should further generate the provisional Candidate Register which the candidates should view and physically sign against their names once they verify that the details captured in the OCRS are correct. It is therefore this same provisional register which the ECZ uses to amend and consolidate from various examination centres before the Final Register is published.

It should be mentioned that a candidate is eligible to sit any ECZ examination only when the examination centre has correctly captured the candidates details in the OCRS, the candidate has paid the prescribed examination fees where applicable, the candidate has verified his/her personal details and signed against their names in the provision register generated at the examination centre and the entries have been accepted by the ECZ. Therefore, if candidates do not verify their personal details in the provisional register, it is assumed that their details are correct when the document is received at the ECZ. So, these details will filter through to the issuance of the statement of results and later on-the certificate.

The other mistake made by the candidates is at the time the examination results have been announced. We reiterate and urge the candidates to ensure that when the results are announced and the statement of results are issued, they should at all times ensure



that they check and verify the details on the results transcript. If they notice any anomaly, it is the duty of the candidate to engage the examination centre/ school to officially write to the ECZ to effect the changes.

As a matter of policy, the ECZ has a defined period in which it resolves examination queries. This is a legal window in the ECZ examinations cycle in which it attends to all the queries related to results. For the Grade 9 External and GCE, the deadline for submission of queries is 31st December in the year of the examination. For the Grade 7 and 9 Internal, it is 31st March following the year of the examination. For the School Certificate (Grade 12) and Teacher Education, it is 31st May following the year of the examination. We strongly encourage candidates to adhere to these deadlines so that examination queries are resolved by the ECZ.

It is imperative that candidates strictly adhere to the prescribed registration guidelines as stipulated in the Guidelines for the Administration and Management of Examinations in Zambia. Therefore, candidate registration will always be critical as the ECZ endeavours to implements new examination reforms. We are hopeful that for the 2020 examinations candidates are going to follow the registration guidelines so that there would be none if not fewer queries at the end of the examination process.

#### e-Statements of Results a Reality

Meeting an institution's vision requires well thought plans and strategies especially those that are inclusive or benefit the communities. The ECZ 's vision of "An Examining Body of Excellence" synchronizes with quality service provision in this sense by introducing e-Statements to candidates.

The ECZ has developed a system for the provision of Statements of Results (SOR) online. The 2018 examinations were the last to use manual Statements of Results meaning that a

phased approach has been adopted and ECZ will only print replacements for 2018 SOR in case one loses it.

This innovation of accessing results online by candidates will help reduce on the production costs and will help the ECZ save its stakeholders more effectively through prudent resource management. Results will be made available online once they are announced by the Ministry of General Education and ECZ is working in consultation with the stakeholders to realise this innovation for industrialization and inclusive growth that contributes to sustainable development of the nation.



### Digitisation of Examination Records

In this new era of Information and Communication Technology, document digitisation is one of the critical issues organisations need to look at to remain competitive and achieve operational efficiency.

It is best to opt for this new and improved way of documentation today and leave all the old and dusty ways of filing and documentation aside. In other words, digitisation involves the conversion of an object, document or an image into electronic format. It means converting an original, source record and is usually carried out through scanning or photographing the source record.

In line with its strategic objective of automating the records management at the ECZ in the light of challenges resulting from increased workload and limited physical space, the Council has made strides towards the digitisation of

examination records. The examination records earmarked for digitisation are School Certificate and General Certificate of Education. The two levels have been singled out because of their demand especially from people who want to gain entry into tertiary education or are seeking employment.

For the ECZ, the digitisation of examination records will not only make the provision of various council services easy but also will avoid the loss of records since they will be safe in a central documentary server.

Digitisation will also avoid any loss of time since several people can retrieve the documents from different places and departments in case of actual files and documents. With such automation at ECZ, digitisation will save a lot of time and effort that can go into something more productive.

Worth noting is that the digitisation of records will improve security of information. This is because the access to information and documents is maintained in a secure and structured manner. With the current expansion programme through the creation of service centres in strategic locations, the responsible officers managing these facilities will be in control to define the different access permissions to the data and documents within the document management system.

The efficiency and ease-of-use of document digitization are indisputable, but the eco-friendly aspect of going paperless is an added incentive for the ECZ. Therefore, the automated records management system at the ECZ will form a vital link to the efficient service delivery and assurance of safe custody of critical records for the office, clients and stakeholders.

In its pursuit to provide the most appropriate communication infrastructure to ensure that information reaches the public using the most effective media platforms, the ECZ has continued to participate in the Zambia International Trade Fair (ZITF) and the Zambia Agricultural and Commercial Show (ZACS).

The two national shows provide a premier forum and a platform of choice for the ECZ to showcase its products and services with a view to create sustainable partnerships with stakeholders and the public. The occasion also provides an opportunity for advisory services on matters of examinations and certification.

Since 2012, the ECZ has also been providing instant council services to members of the public during the shows. These council services include verification of results, Combinations of Grade 9 Results, Accumulations of GCE Certificates, Certificate Replacements, Equating of foreign qualifications to the Zambia standard as well as pre and post examination queries.

In the 2019 ZITF and ZACS, the ECZ received a total of 728 requests from members of the general who were seeking Council services during the shows. Of the total requests, there were 625 results verifications, 21 Grade 9 Combinations, 69 Accumulation of GCE Certificates, 12 Certificate Replacements and 2 Foreign Results Translations. This outlook shows that a lot of people are now aware and appreciate the importance of accessing services from the ECZ for different purposes.

The 2019 Grade 7, 9 and 12 Examinations have been set to run in the month of November as part of the call to enhance security of examination materials which were prone to tampering when they were stored for longer periods in the examination centres.



# ECZ Pledge to Partner with Zambia Police Service

The ECZ and other Governance stakeholders have pledged to work with the Schools Liaison Unit of the Zambia Police Service to fight delinquency among the youths in learning institutions and other communities.

The resolution was arrived at during the Breakfast Meeting held on 22nd February 2019 at the Lusaka Hotel organised by the Zambia Police Service. Held under the theme, "Enhancing Partnerships in Promoting Safer and Crime Free Environment," the purpose of the Meeting was to identify mutual ways in which the School Liaison Unit can collaborate with other organisations to fight delinquency among the young people.

Other stakeholders invited to the Meeting were the Ministry of General Education, Ministry of Health, Zambia Information and Communication Technology Authority, Road Transport and Safety Agency, United Nations International Children's Emergency Fund, Zambia Breweries, Drug Enforcement Agency and others. The stakeholders present resolved to collaborate with Zambia Police Service to ensure that crime was prevented and the young people are inculcated with values that would make them responsible citizens.

The School Liasion Unit is one of the sections under the Community Service Directorate in the Zambia Police Service with the mandate to prevent crime in schools and earning institutions. To a larger extent, the Unit advocates for proactive methods in it's advocacy activities such as Radio and Television awareness, distribution of information and education materials on human trafficking, child abuse, sexual harassment, abduction, examination malpractices and drug abuse

For the ECZ, the Breakfast Meeting provided an opportunity to share the challenges it was battling with regarding the occurrences of examination malpractices especially during school examinations. The stakeholders further pledged to assist the ECZ through the creation of synergies by including issues of integrity and honesty in their programmes as they interacted with the young people in the Zambian schools and communities.

### Chipata, Kasama and Livingstone **Service Centres to open in 2019**

Important arguments in favour of decentralization are that it creates an efficient and reliable administration, intensifies and improves development, better ensures the rights of the local population to have a voice in Government, better protect minorities and bring the provision of public services closer to the people.

Under this backdrop, the Government of the Republic of Zambia through the Ministry of General Education and the ECZ is moving steadily in ensuring that public services are brought closer to the people. In line with the Government's Decentralization Policy, the ECZ even in 2019 will open regional offices where all Council services will be accessed by the public. As part of the expansion programme, four regional office so far have already been established and these are Lusaka, Kitwe, Mpika and Mongu Service Centres.

The planned expansion programmes through decentralization of Council Services will this year see the ECZ opening up Service Centres in Chipata, Kasama and Livingstone. The three ECZ Service Centres will cater for clients from eastern, northern and southern provinces. This move will support local people to access educational support services without traveling long distances. This will in turn help people to channel the saved time on other productive businesses thereby helping to boost economic growth.

Like the other Centres, the new Service Centres will be set to provide Council service such as; verification of school results, combination of Grade 9 results, accumulation of GCE results, replacement of certificates, translation of foreign results, renewal of examination centre status for private schools and many other pre and post examination services once the facilties are officially opened.

With the creation of regional offices, the Council is optimistic that the decentralization programme will go a long way towards taking the ECZ services closer to the people and fulfilling the Zambian Government's promise of efficient public service delivery.

### **Government Commends ECZ for Innovations**

Permanent Secretary Administration in the Ministry of General Education Dr Jabbin Mulwanda has congratulated the ECZ on its innovations to improve service delivery to the Zambian People.

Dr Mulwanda spoke during a familiarization meeting held at the ECZ Main Offices along Haile Selassie Avenue in Longacres Lusaka on 30th May 2019. He noted that despite the challenges ECZ was facing, the institution had made great strides to improve the way business was conducted. "Through the challenges, ECZ has seen opportunities and has done something towards them," he said.

Speaking at the same meeting, ECZ Director, Dr Michael Chilala outlined some of the developments that had taken place in the ECZ since 2014. He noted that ECZ had embraced ICT through the introduction of the online candidate registration system, the electronic item banking system, digitization of records that were in hard copy form, electronic marks capture system and the online access of Statements of Entry.

He also mentioned that ECZ working with the Ministry of General Education had rezoned schools to enhance security in the storage of examination materials. He stated that the ECZ had adopted School-Based Assessments (SBA) as a measure to meet quality education standards and widen the skills and techniques to which learners were

exposed as opposed to one-off test. "One-off tests are not enough to assess the skills and so the school-based approach will broaden the learning achievements," he said.

Dr Chilala also stated that the ECZ had syllabi developed the examination which have been made available to the public through Bookworld Africa Stores countrywide. He further disclosed that the ECZ had reduced the number of examination papers at Grade 12 from 74 to 50 as a result of some learning outcomes that were duplicated. "We have also automated the procurement and payroll system and have carried out research on behalf of the Ministry." Dr Chilala said.

He said that the FC7 had introduced midyear Grade 9 and GCE Examinations and has conducted exams at Grade 7 level at a school in South Africa called St Jeff College Primary School. "The school results have been released on time and are made accessible via mobile phone and the marking of GCE Scripts has been decentralized to which we foresee an improvement in the learner performance as teachers involved in marking have been increased," Dr Chilala stated.

The ECZ Director further stated that the council had opened Customer Service Centres in Lusaka, Kitwe, Mpika and Mongu and hoped to open more by the year 2021 with resources allowing.

#### Answer:

No, the online verification has not started. However, the good news is that we have made strides in the development of the system to have it up and running. All things being equal, the system should be operational by the end of 2019.

#### **Combination of Results**

How much is combination of grade 12 results? And how many days does it take?Trywell Ngo'mbe

#### Answer:

According to ECZ policy, we do not combine Grade 12 results but we combine GCE Certificates in order for you to have an Accumulated GCE Certificate. The Grade 12 Results and GCE Results are two different sets of results undertaken at different intervals with different conditions within the examination cycle. The accumulation of GCE Certificates is K1000 and at most it takes 10 working days for the document to be ready. All the best

#### **Refund of GCE Examination Fee**

I am kindly asking if it is possible to refund someone for GCE examination fee if they happen not to write due to sickness?By mmukazo

#### Answer:

It is not possible for the ECZ to refund. According to the Guidelines for the Administration and Management of Examinations in Zambia, examination fees are not transferable.

#### **Verification of Results**



It is also a time to take a postmorten of the challenges encountered during the year and make appropriate recommendations to improve the conduct of examinations.

# Avoiding Stress at work

For so many reasons in our lives topped by work, we unwillingly have to experience stress. Actually it is taken for granted that whenever there is work, defiantly there is stress. This could be for several reasons starting from the fear of being laid off, or being pressured to work at optimum levels all the time, to lack of control on your own schedule. So, employees should really know how to avoid stress, and how to handle it whenever they have to. There are some tips of how to avoid stress at the first place: According to thinkmarketingmagazine.com (2019), here are the seven (7) tips to avoid stress at work:
